# 1 FUNDING AND SUPPORT BY THE ARTS PROMOTION CENTRE FINLAND (TAIKE) IN 2017

- The operations of the Arts Promotion Centre Finland (Taike) comprise of support for artistic and cultural activities in the form of awarding grants and subsidies, as well as development and project activities that are implemented primarily by regional artists employed throughout Finland. These two assignments constitute arts promotion<sup>1</sup>.
- In 2017 Taike supported artistic and cultural activities through grants, subsidies and awards amounting to 35,3 million euros. This amount represents a 3 percent growth which is over 1 million euros more than in the previous year. Primarily this growth is explained by a new form of support<sup>2</sup> as well as the role of a key project<sup>3</sup> of the government.
- Including the work of regional artists as well as other arts promotion work performed by the centre, a total of 37,6 million euros was spent for the promotion of arts and culture in 2017. When compared to the previous year, this figure represents a growth of close to three percent.
- The funds used for arts promotion come from two sources. Statutory support in the form of state artist grants and grants for writers and translators (i.e. library grants) is paid from the state budget<sup>4</sup>. Other discretionary support is paid from lottery funds, which account for 58 percent of the funds allocated for arts promotion.
- When compared to the previous year, funds for most of Taike's support schemes remained largely the same. Some of the changes that have occurred are due to the movement of funds to another budget article. For example, the subsidies for the advancement of multiculturalism have decreased by 19 000 euros because that sum has been added to multicultural project grants. Real increase only occurs in the key project support (expanding the one percent rule) of the Sipilä government. Decrease, on the other hand, has occurred in the "actual" percentage art (one percent of construction costs for arts) support scheme.



- Taike support is divided into national support and regional support. A total of 31.9 million euros was awarded in national support schemes in 2017, which is over 900 000 euros more than in the previous year. As has been the case in previous years, the visual arts, literature and theatre accounted for the largest shares of national support.
- A total of 3.4 million euros was awarded in regional support schemes in 2017, which is on the same level
  as in the previous year. The visual arts and music accounted for the largest shares of this regional support.
- Altogether the four largest artforms literature, the visual arts, theatre and music accounted for 58 percent of support awarded by Taike.
- The share given to different artforms has, for the most part, remained the same. However, the introduction of new artforms has diminished the share of the "old" artforms.

- The distribution of total funding among the various artforms either remained broadly the same or grew slightly compared to previous years. Relatively, the largest growth occurred in the group "culture", which includes three support schemes that cannot be categorized by different artforms <sup>11</sup>. Compared to the previous year, this field grew by 82 %, close to 900 00 euros. This growth was mainly due to a new support scheme delegated from the Ministry of Education and Culture to Taike (the promotion of cultural activities by disability communities 691 000 euros) as well as increases to previously transferred support schemes.
- In relative terms, light and sound art and environmental art grew the most though both are quite small artforms and therefore even a minor growth appears large percentagewise. Light and sound art grew 60 000 euros compared to the previous year (+74 %) and environmental art grew slightly over 20 000 euros (+28 %).
- Compared to the previous year, support for some artforms decreased (i.e. architecture -8 %, photography -3%).



• Following Taike's restructuring (2013), the decision-making authority for the use of appropriations is divided between the arts councils and the agency (director). In 2017, 63 percent of the support by Taike was decided by the arts councils and thus peer-reviewed. There were, however, significant variation between artforms. For example, nearly all the support for arts journalism, illustration and literature is decided by the arts councils (including regional arts councils and the Board for Grants and Subsidies to Writers and Translators), whereas only around a third of the support awarded by Taike for performing arts (theatre, circus and dance) was decided by the arts councils. Funding decisions for artforms for which a large amount of operating subsidies are available are made increasingly by the agency.

### 2 TAIKE DEVELOPMENT PROGRAMMES 2017

- In 2017, 2.2 million euros and 40 man-years of regional artists were spent on Taike development programmes.
- Children's and youth culture activities were targeted to areas where the child's right to art is less realized (i.e. areas lacking in children's culture operatives or without a culture education plan). According to the objectives of the development program, 1/3 of the projects should be targeted for the youth. In 2017, half of the projects were allocated for the youth.
- The objective for the development program for cultural diversity and mobility was that 25 % of projects should be related to the interaction between the immigrant population and the original population. This goal was not completely met, as only 16 % of the projects targeted the aforementioned interaction. Another focus of the program was minority cultures (e.g. "Kotimaani ompi Suomi, Romanit 500 vuotta 100-vuotisessa Suomessa" -project). Concerning mobility, the development of the artist residency concept was continued with a focus on Nordic connections.
- In the development programme for the principle "1 % of Construction Costs for Art", expansion for municipalities and other constructors were added. A total of 12 projects with 20 artists received support from Taike.
- In the development programme for the use of art to promote wellbeing, attention was paid to the geographical expansion of the social welfare and healthcare sector funding. Taike participated in the series of regional events for the promotion of wellbeing, health and ability to work organized by the Ministry of Social Affairs and Health.
- Taike's largest development programme is focused on the working conditions of artists. The operational model of the development program was further polished through the creation of a preliminary report for a future development program concerning artistic expertise and intermediation. As a pilot, Tanssi talon kanssa cooperation consisted of a broad report of tour activities. Regionally, certain fields were emphasized: bio art, performance art, visual arts, light art, media art, comics, art jewellery and literature, among others. Common themes present in these events and projects were the Suomi 100 -celebration year as well as Taike's Oma Taide Liikuttaa.
- Expertise work included statements serving as participation in municipal planning work. In some municipalities, experts were involved with the planning work itself (1,3 man-years).

### 3 TAIKE SUPPORT FOR INTERNATIONALIZATION IN 2017

- In 2017, over 740 000 euros were allocated in mobility grants<sup>13</sup> and Artist-in-residence subsidies for the support of internationalization<sup>14</sup> by Taike.
- Other support schemes were also used to support the international activities and art projects. Project grants and special subsidies for international activities amounted up to almost 600 000 euros<sup>15</sup>. In project grants, the largest share of allocation for international activities were in design and music.
- In 2017, almost 50 000 euros was spent on international projects within Taike development programmes.
- Of all the grants and subsidies targeted towards international activities, visual art accounted for the largest share (26 %)
- The support for international activities from different support schemes grew 26 % compared to the previous year. However, funds that were "earmarked" for internationalization have remained the same. Instead, project grants and special subsidies allocated towards international activities have increased, though this growth is likely due to improved monitoring in 2017, for the first time, the information was based on the application form.

### 4 APPLICATIONS RECEIVED AND APPROVED BY TAIKE IN 2017

In 2017<sup>16</sup> Taike received 13 980 grant and subsidy applications, almost 400 more compared to the previous year<sup>17</sup>.



# 5 TAIKE GRANT AND SUBSIDY APPLICANTS AND RECIPIENTS BY ARTFORM IN 2017

- 7 600 applicants applied for Taike's grants or subsidies in 2017. When examining the number of applicants, a downward trend persisted. However, compared to the previous year, the difference was only around twenty applicants. The drop in the number of applicants was most noticeable in the field of literature (- 10%). The number of applicants increased in visual arts (+4%) and music (+5%). Relatively, the largest growth occurred in illustration (+37%, a total of 33 applicants).
- Of the applications, 72 percent came from private individuals, 10 percent from working groups and 17 percent<sup>18</sup> from communities. The share of community applications was larger (compared to other artforms) in cinema (28 %), multidisciplinary art (28 %), and dance (27 %).
- Close to 3 200 (42 %) of applicants sent multiple applications. Compared to the previous year, this represents a growth of approximately 2 percent. Over 2 000 applicants applied for both national and regional support. Most of these came from visual arts (37 %) and circus (30 %).


#### APPLICANTS OF GRANTS AND SUBSIDIES (%, N = 7 619) FROM TAIKE BY ARTFORM IN 2017


- 2 868 applicants received grants and subsidies from Taike. Compared to the previous year, the number of recipients is 3 % smaller, which is most likely due to larger support allocations. Applicants receiving support from Taike were comprised of private individuals (74 %), working groups (2 %) and communities receiving state subsidies (24 %). The largest groups receiving grants and subsidies were literature (20 %) and visual arts (18 %), as was the case in previous years.
- 16 percent of recipients received multiple grants. The share was a couple of percentage units smaller than in the previous year. The majority from this group received more than one grant/subsidy from Taike's national support schemes.
- Grants received by individuals (incl. working groups) varied from 250 euros to almost 30 000 euros. The median figure of grants that where allocated was 5 000 euros.






38 percent of applicants received a positive decision. Largest share of positive decision was in the "culture" group, where more than half of the applicants received a positive decision. The second largest share was in architecture, where almost half of the recipients received a positive decision. The lowest share of positive decisions was in multidisciplinary art.

Only a little over one tenth (12 %) of applicants for national 0,5 – 10-year working grants (artist grants) received a positive decision. The lowest recipient share was in illustration, multidisciplinary art, visual arts and media art.

### SHARE OF ARTIST GRANT RECIPIENTS (%) FROM APPLICANTS BY ARTFORM IN 2017\*



### **6 GRANT APPLICANTS AND RECIPIENTS IN 2017: REGION, LANGUAGE**

- Almost half of Taike grant applicants and recipients were from the Helsinki Metropolitan Area. The share
  of applicants living in the Helsinki Metropolitan Area was roughly the same as it was the previous year,
  however the share of recipients fell (51 % → 48 %).
- The differences between artforms were large. The share of applicants living in the Helsinki Metropolitan Area was largest in the fields of architecture, arts journalism and media art, and lowest in literature, visual arts, comics and multidisciplinary art.







## 7 GRANT APPLICANTS AND RECIPIENTS IN 2017: AGE, GENDER

- Among all Taike grant applicants (individuals excluding contact persons for working groups), more than
  one fifth were young people under the age of 35. Relatively, the highest share of applicants under the age
  of 35 were in the fields of circus (48 %), comics (36 %) and dance (35 %). The lowest share was in the field
  of literature (11%). Only a couple of applicants and recipients in the fields of architecture and arts journalism were under the age of 35.
- The average age of Taike grant applicants in 2017 was 43. The youngest were applicants in the fields of circus (35) and dance (38). The oldest were in the field of literature (49).
- The average age of grant recipients was 44. The average age of grant recipients by artform was similar to that of the applicants.


#### SHARE OF APPLICANTS AND RECIPIENTS (%) UNDER THE AGE OF 35 IN 2017 (INDIVIDUALS)



- The share of women among Taike grant applicants and recipients was over half but varied according to artform. The share of women was highest in the fields of dance and illustration and lowest in the fields of light and sound art and music. However, in the latter the share of women rose to 40% of grant recipients, a first in recorded history.
- In most fields, the share of women among grant recipients was similar to their share among applicants. In the fields of dance, illustration and cinema, the share of women from grant recipients was higher than their share from applicants. In some fields, the share of recipients was smaller than the share of applicants. This was the case in, for example, the fields of architecture and environmental art.

### **8 REQUESTS FOR RECTIFICATION 2017**

- According to the law on the Arts Promotion Centre that came into force at the beginning of 2013, rectification may be requested regarding grant and subsidy decisions. Since the beginning of 2016, this amendment to the law applies to grants for writers and translators (library grants) and grants for visual artists (public display grants). In addition, since 2016 the possibility to request rectification has been included in artist pensions, which have been moved to Taike from the Ministry of Education and Culture.
- Taike received altogether 44 requests for rectification regarding decisions made in 2017. This is 10 fewer than in the previous year.
- The share of requests for rectification out of all the applications was 0,3 percent.
- Most of the requests for rectification (31) were made by individuals, and most (20) related to decisions on artist pensions.
- The requests for rectification concerned eight different artforms, with most requests in the fields of music (12) and literature (11).
- The majority of requests for rectification (34) concerned support schemes in which the decision was made by the agency, not a council.
- 42 requests for rectification were rejected as groundless and two were not considered at all, as they did not arrive within the due date (30 days).

### 9 ARTIST PENSIONS 2017

- In 2016, The Ministry of Education and Culture transferred the state's extra artist pensions under the decision-making authority of Taike whilst also enacting a law on extra artist pensions.
- In its current form, artist pensions have been allocated since 1974. Artist pensions became statutory in 2016<sup>20</sup>
- According to law, an extra artist pension can be given to an artist who lives (or has lived) in Finland
  permanently, as a recognition for laudable work as a creative or performing artist. Unless there is an
  extraordinary reason, the pension cannot be given to a person younger than 60 years old.<sup>21</sup>
- During the 2010s, the number of artist pension applicants has annually been about 500, most coming from the fields of music and visual arts. The share of women is low, roughly a third of all pension applicants and for example only one tenth in the field of music.
- In 2017, there were in total 518 artist pension applicants. 61 of these received either a full or halved pension.

### **10 YEAR-ON-YEAR CHANGES, 2016 – 2017**

- Taike support for the promotion of art and culture (37.6 million euros) increased by almost 3 percent over the previous year. This support accounted for 0.07% of state expenditure and 8.1% of the state art budget<sup>22</sup>, which is on par with previous years.
- Taike support for artistic and culture activities through grants, subsidies and awards amounted to 35.3 million euros in 2017, representing an increase of 3 percent over the previous year. For the most part, the increase is explained by a new support scheme that was transferred to Taike, and an increase to the government key project (expanding the "1% of construction costs for art") support.
- A support of almost 1.4 million euros was targeted towards international activities in 2017. This represents an increase of 26 percent over the previous year. This increase is caused by improved monitoring.
- Taike received close to 14 000 applications for grants and subsidies in 2017, which is almost 400<sup>23</sup> more than in the previous year. The number of individual applicants decreased by 20 over the previous year, which indicates a less pronounced continuation of the downward trend that began in 2013. The number of grant and subsidy recipients also decreased over the previous year (- 3%).
- The number of applicants with more than one application (over 3 100) was slightly higher than in the previous year (approximately 100 applicants).
- Both national and regional support was applied by more than 2 000 applicants. This number represents an increase of a couple of hundred applicants.
- The share of applicants and recipients by different artforms remained largely the same. Again, the share was highest among applicants and recipients of visual arts and literature. However, the share of these two artforms has decreased slightly, given that previously these applicants made up almost half of all applicants compared to 39 percent in 2017.
- The share of recipients out of all the applicants was similar when compared to the previous year (38 %). Again, the differences between artforms were large. In multidisciplinary art and arts journalism, the share of positive decisions was roughly one fifth, whereas in architecture, literature, circus and dance the share was over 40 percent. More than half of the applications concerning culture received a positive decision.
- The average age of both the applicants and recipients of Taike grants was on par with previous years 44 years for applicants and 43 for recipients. Between different artforms, the average age varied from 35 in circus to 49 in literature.
- The share of younger applicants under 35 years old was still low. From all the grant applicants, the share of applicants under the age of 35 was close to that of the previous year (22 %), and from recipients the share was 19 percent in 2016 these were 21 and 18 percent.
- The share of women from all the applicants and recipients was on par with previous years. Most notable
  change occurred in the field of music, where for the first time on record the share rose to 40 percent. In
  spite of this increase, music remains one of the most male-dominated artforms in Taike.

- The share of applicants and recipients living in the Helsinki Metropolitan Area was similar to the previous year. The share of recipients decreased by a couple percentage units (51 %  $\rightarrow$  48 %).
- The share of Swedish-speaking applicants was the same as in the previous year (5 %). The share of Swedish-speaking recipients decreased by one percentage unit (5 %  $\rightarrow$  4%).
- The share of non-native speakers<sup>24</sup> among grant applicants and recipients in state support schemes was also the same as in the three previous year (5%).
- The number of requests for rectification decreased by 10 from the previous year.
- The number of applicants for artist pensions increased by 14. The number of pension (either whole or halved) recipients increased by two compared to 2016.



### 11 TRENDS 2013 - 2017


• The funds of the Arts Promotion Centre for the promotion of art and culture have grown slightly during the past five years. For the most part, this growth is explained by support schemes delegated to Taike from the ministry. Between 2016 and 2017, a new delegated support scheme was a subsidy for promoting the cultural activities of disability communities and the accessibility of culture (691 000 euros).

## Taike funds for the promotion of arts and culture (€ million) in 2013-2017




• During the past five years, national support (subsidies, grants and awards) has grown by 12 percent. Concurrently, regional support has decreased by nine percent.

• The grant allocation for private individuals and working groups has grown by close to 1 000 000 euros (5 %) during the past five years, while the support targeted for communities has increased by over 2,5 million euros (24 %) during the same time period. The increase in the support for communities is mainly explained by the support schemes delegated to Taike from the Ministry of Education and Culture.


# Taike grants\* for individuals and subsidies for communities € in 2013 - 2017

- Since the beginning of the support structure (1968), the largest share of support from the Arts Promotion Centre (and its predecessor The Arts Council of Finland) has been allocated to "the big four": literature, visual arts, music, and theatre.
- During the last five years, the share of the "large" artforms has either slightly decreased or remained approximately on the same level. The share of visual arts increased until the year 2014. In 2015, the share of dance increased substantially, however this increase was technical and caused by the regional center support for dance that was transferred from the Ministry of Education and Culture to Taike.
- When examining these trends, it should be noted that the amounts of support have been calculated from a wide variety of different funds that are not uniformly expressed in the state budget or necessarily "earmarked" for specific artforms<sup>25</sup>

### Taike support\* in 2013 – 2017 "large artforms" (over 1,0 million euros support)



• From the so-called "small" artforms, the support for e.g. media art and circus have experienced steady growth. In contrast, the support for architecture has been decreasing for several years and the support for arts journalism has remained quite low. The relatively new category of illustration has been increasing its amount of support in a steady fashion.


### Taike support\* in 2013 - 2017, "small artforms"

• In terms of grants allocated for individuals and working groups, the relative share between the "large" artforms remains approximately same. The exception is cinema, where a large share of funds is allocated as community support (operational and special subsidies, incl. quality support of cinema). If one examines grants allocated only for individuals, the share of cinema is the lowest among the "large" artforms. Compared to the previous year, the grants for cinema have remained the same. This is true for other fields as well, as the amount allocated as grants has retained its established level.


# Grants allocated for individuals<sup>26</sup> in 2013 – 2017, "large artforms"


• When only the grants for individuals and working groups are examined, the arrangement between the so-called small artforms changes as well – for example, media art will move past circus. The average yearly growth of every small artform is positive over the last five years. The small, relatively new (according to the art administration categorization) artforms such as illustration and comics grew the most. In contrast, the field of architecture experienced a continuation of a downward trend.

### Grants allocated for individuals in 2013 - 2017, "small artforms"




• In terms of the *national* support schemes of individuals and communities, the differences between different artforms are less pronounced than in grants allocated for private individuals. The highest average yearly growth occurred in comics (24 %) and dance (12 %). The growth in dance is explained by the delegation of the regional center support to Taike.

### Support allocated through national support schemes in 2013 – 2017, large artforms




### Support allocated through national support schemes in 2013 – 2017, small artforms



### Support through regional support schemes (€) 2013 - 2017, large artforms




## Support through regional support schemes (€) 2013 - 2017, small artforms




• The amount of funds spent on projects of the Arts Promotion Centre varies both yearly and between different regions. Between 2011 and 2015, the amount has decreased by almost a quarter (23 %). Between 2013 and 2014 the funds for projects grew by a few percentage units, but by 2015 it again decreased. the reason behind this decrease is that the regional funds for arts promotion have been targeted for i.a. administration costs.


### Funds for Taike projects/development programmes 2013 - 2017 (€)



### Targeted funds for Taike development programmes 2015 - 2017




#### Regional artist salary expenses 2013 - 2017




- The Arts Promotion Centre's support for internationalization has varied quite heavily through the years, especially during the latest observed years. The main reason behind this variation is a more accurate source of information and a more widened definition of the term.
- Previously, the support for international activity was considered to form through separate mobility grants
  and subsidies, project grants and special subsidies of different fields that have been allocated for activities
  abroad, international projects and the Taike supported artist residencies abroad. The 2017 statistic includes regional support schemes, but the largest advancement of in measurement has come from sourcing the information from the application form, where the applicant himself/herself has marked whether
  there is international (abroad) activity in the project.

- If the latest observed year is not included, the amount of applications received by the Arts Promotion Centre has decreased in the last five years. The growth in the latest year is mainly explained by new support schemes. Again, individual applicants sent multiple applications to Taike. In 2016, over 3000 applicants submitted two or more applications.
- The number of approved applications has steadily decreased. This is explained, in part, by higher sums in allocated grants in some fields. However, in whole, the sum of allocated grants has not grown significantly.


#### Number of received and approved applications in 2013 – 2017

- The downward trend in applications in previous years seems to continue. The lowest average annual growth has occurred in the field of design. Only cinema, media art, circus, arts journalism and comics have had average annual growth.
- The number of grant and subsidy recipients has also decreased (annually on average -5 %). The largest decrease occurred in the fields of design, literature, and multidisciplinary art.







Share of applicants and recipients under the age of 35 (%) for Taike grants in 2013 - 2017










# Share of grant/subsidy applicants and recipients living in the Helsinki Metropolitan Area in 2013 - 2017



## Number of grant/subsidy applicants and recipients living abroad in 2013 – 2017




The share of Swedish-speakers among applicants and recipients of Taike grants (%, private individuals) in 2013-2017\*


The share of non-native speakers among Taike applicants and recipients\* (%, private individuals) in  $2013 - 2017^{27}$ 




